## EuroLink

Non-Statutory Public Consultation  
October – December 2022

To support the UK's growing energy needs, National Grid Ventures (NGV) is bringing forward proposals for a multi-purpose interconnector (MPI) called EuroLink, which will deliver a new electricity link between Great Britain and the Netherlands.

EuroLink could supply up to 1.8 gigawatts (GW) of electricity, which would be enough to power up to approximately 1.8 million homes, as well as contribute to our national energy security and support the UK's climate and energy goals.

We are holding a non-statutory public consultation to share our proposals for EuroLink and gather feedback, which will be used to help refine our plans, and respond to your questions.

### Key benefits

EuroLink will deliver a range of nationally strategic benefits, including:



**Improving affordability of energy**

Import cheaper energy for consumers by moving energy from where there is excess and the price is low to areas that need it and where prices are high.



**Enhancing our national energy security**

Deliver energy security by managing rapid changes in energy supply and demand.



**Supporting zero carbon energy**

Efficient links for zero carbon energy with 90% of electricity imported via National Grid interconnectors set to be from zero carbon sources by 2030.

## Coordination

In response to stakeholder feedback, NGV and National Grid Electricity Transmission (NGET) are exploring:

- opportunities to coordinate NGV's projects, EuroLink and Nautilus, and NGET's project, Sea Link, including separately consulting on shared: converter station sites; cable route corridors; and landfalls
- opportunities with other developers to minimise the impact of construction on the environment and local communities
- offshore coordination with other developers as part of the Offshore Transmission Network Review

In exploring these opportunities to coordinate, NGV's EuroLink and NGET's Sea Link are consulting at the same time. We hope that by sharing our proposals, people feel better informed about how different parts of the infrastructure could fit together and can share their views on each of the projects accordingly.

## We want to hear from you

The non-statutory consultation will commence on **Monday 24 October** and will run for eight weeks until **Sunday 18 December**.

Your feedback will help us refine our proposals and identify our preferred locations for onshore infrastructure.
